Dropoff Type – Identifies the method by which the package is to be tendered to FedEx. This element does not dispatch a courier for package pickup (i.e. Business Services Center, Drop Box, Regular Pickup, Request Courier, Station); defaults to Regular Pickup.

Recipient Location Number – A unique identifier for a recipient location.

Block Insight Visibility (True/False) – If True, only a shipper/payer will have visibility of this item.

Edit Request Type – Specifies whether the customer wishes to have Estimated Duties and Taxes provided with the rate quotation on this shipment. Only applies with shipments moving under international services (i.e. All, None).

Delivery Instructions – Any special instructions. String value.

Shipping Charges Tab

This will all be defaulted to the Shipper setup in Carrier Setup. You only need to change this if someone else is paying for the shipping charges rather than who was initially set up.

Payment Type – Dropdown with Account, Collect, Recipient, Sender, and 3rd Party selectable; defaults to Sender.

Account Number – Defaults to Account number setup in Carrier Setup if not filled in.

Person Name – Defaults to Attention setup in Carrier Setup if not filled in.

Title – Sets the title of the person who will be paying.

Company Name – Defaults to Company Name setup in Carrier Setup if not filled in.

Street Lines – Defaults to Address 1 and 2 in Carrier Setup if not filled in.

City – Defaults to City setup in Carrier Setup if not filled in.

State or Providence Code – Defaults to State setup in Carrier Setup if not filled in.

Postal Code – Defaults to Zip setup in Carrier Setup if not filled in.

Urbanization Code – Optional; relevant only to addresses in Puerto Rico.

Country Name – Defaults to Country Name setup in Carrier Setup if not filled in.

Country Code – Defaults to Country Code setup in Carrier Setup if not filled in.

Percent Value – Sets the percent of the total handling charge if charge is to be calculated.

Rate Element Basis –Sets the charge you would like to apply the percent value to for calculating the handling charge (i.e. with Base Charge, Net Charge, Net Charge Excluding Taxes, Net Freight).

Rate Type Basis – Sets the Account or List Pricing.

Currency – Sets the currency type for the fixed rate option; defaults to Dollars.

Amount – Sets the amount option for the fixed rate option.

Clearance Brokerage – Sets a broker option used for international shipments (i.e. Broker Inclusive, Broker Inclusive Non-Resident Importer, Broker Select, Broker Select Non-Resident Importer, Broker Unassigned).

Document Content – Dropdown with Derived, Documents Only, Non Documents selectable. Sets the documents that are going along with the shipment.

Freight On Value – Sets who is responsible for any damage to the package (i.e. Carrier Risk Own Risk).

Parties To Transactions Are Related – Indicates whether the sender and recipient are subsidiaries or divisions of the same company or are unrelated.

Regulatory Controls – Sets regulatory controls (i.e. EU Circulation, Food or Perishable, NAFTA).
